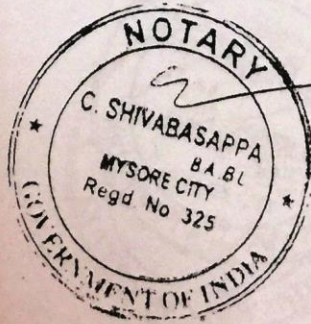

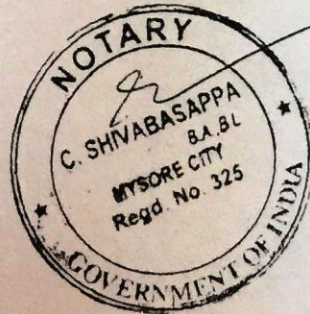

**THE CONSTITUTION OF THE "SAMMILANA"**

**(J. S. S. DENTAL COLLEGE ALUMNI)**

**MYSORE - 570 015, INDIA.**

**01. NAME:**

The name of the Association shall be "SAMMILANA "

**02. AREA:**

The Association shall function and carry on its activities at Mysore. *city* ①

**03. OFFICE:**

Registered office of this Association shall be at Mysore, the venue shall be *JSS Dental College* specifically designated as per availability and convenience. *Shreekrishna Nagar Mysore* ②

**04. AIMS AND OBJECTIVES:**

The aims and objectives of the Association shall be;

A) To cater up-to-date scientific knowledge to all the members of the Association based on the current developments, research and innovations in the field of dentistry. A free library facility (library of J. S. S. Dental College and Hospital, Mysore,) shall be provided for all the members for the above purpose and shall take prior permission from the president for the same.

B) To conduct continuing educational programs to the members for the above purpose and for sharing of knowledge.

C) To bring together all the BDS / MDS passed past and present students and teaching staff of the J. S. S. Dental College and Hospital, Mysore, to preserve, protect and promote the interest of the members keeping in view, the changing concepts and practices of Dental profession and duties to uphold the dignity of the profession.

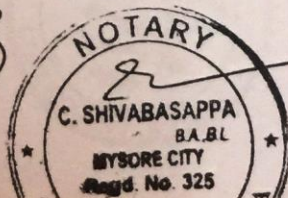
D) To conduct free dental camps, oral cancer detection camps, dental awareness programs for the public.

E) To render free treatment for the economically backward, orphans and physically handicapped people by the members of the association.

F) To provide a venue for get-together, recreation and social interaction of the members of the association and to foster the feeling of unity amongst the members, and

G) To plan and execute all other things necessary for the welfare of the members and for the realization of the above said objectives.

**05. MEMBERSHIP:**

There shall be two classes of members - Honorary and Ordinary.

A) Any person who has been or is rendering distinguished service in the field of dental treatment or education may be elected as an Honorary Member of the Association at a general body meeting by majority votes. An Honorary Member shall not have power to vote.

B) Every person who have passed BDS / MDS degree course from the above college shall be eligible for the admission as an Ordinary Member.

*President/Secretary*

C) Application for ordinary membership shall be in the prescribed form, signed by the applicant and addressed to the President/Secretary. An admission fee of Rs.500/- shall accompany the application. Decision of the executive committee shall be final regarding admissions. The fund shall be deposited in the common account as said in para 16 (C)

D) Every ordinary member of the Association shall pay an annual subscription of Rs. 100/- payable on or before the last day of August every year. The fund shall be deposited in the common account as said in para 16 (C)

E) Honorary members shall not be liable to pay subscriptions. They may however make donations to the Association in cash or kind.

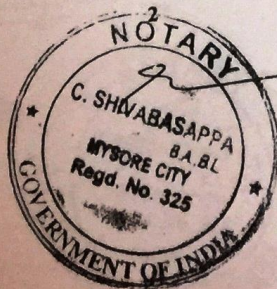
F) All members including honorary members shall pay such amounts decided by the general body to meet any contingent situation or otherwise. Such contributions shall be equated with yearly subscriptions and a defaulter of the same shall be equated with a defaulter of yearly subscription and shall be considered accordingly.

G) Members who fail to pay yearly subscriptions within 30 days of the receipt of a notice from the Association shall cease to be a member of the Association. A ceased member shall be considered as an outsider for every purpose of the Association.

H) A ceased member can apply for readmission along with a readmission fee of Rs.150/- and the arrears of subscription. The fund shall be deposited in the common account as said in para 16 (C)

I) A person shall be disqualified to be a member of the Association-

- a) If he/she is of unsound mind or
- b) If he/she is convicted of any offense involving moral turpitude or found to be guilty of professional misconduct.

In the matter of disqualification, the decision of General Body shall be final.

J) Any member desirous of tendering his resignation from the Association may do so after clearing all his arrears and liabilities with the Association.

#### 06. EXECUTIVE COMMITTEE:

A) The executive committee of the Association shall consist of the President who shall be the Principal of J. S. S. Dental College and Hospital, Mysore, Vice president who shall be the Vice Principal of J. S. S. Dental College and Hospital, Mysore, the Secretary, the Treasurer the Joint Secretary, the Editor and other six members. Secretary, Treasurer, Joint Secretary, Editor and other six members shall be elected from the general body. All members except honorary members shall have power to vote.

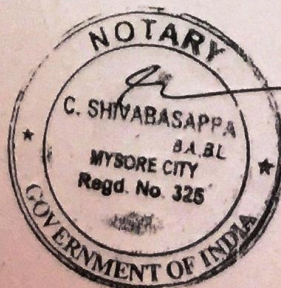
B) The term of office of the Executive Committee shall be for one year, normally from the first day of September to the last day of August every year. The Executive Committee shall conduct election to the new Executive Committee from the general body every year before the expiry of the tenure of the existing committee, under the supervision of a returning officer nominated. All ordinary members who have cleared all dues before the last day of December are eligible to contest the election and have power to vote. Those Executive Committee members who are not secured 75% attendance in the previous year's meetings are not eligible to contest the election.

C) The quorum of the executive committee shall be seven. The Executive Committee shall meet with two days notice to the members of the Executive Committee. Executive committee shall not meet or function without the express consent of the President.

D) Casual vacancies arising in the Executive Committee shall be filled by nominations.

E) The President or in his absence, the Vice president or in his absence, the Secretary or in his absence any other committee member elected shall preside over the committee meetings. The committee shall decide questions before it by the majority vote. When the votes are equal the President or presiding person shall have casting vote.

**07. THE PRESIDENT:**

The President shall be the spokesman of the Association. The Principal of J. S. S. Dental College and Hospital, Mysore, shall be the President of the Association throughout his tenure in the college. In the event the Principal of J. S. S. Dental College and Hospital, Mysore, is unwilling or otherwise incapacitated to take charge of Presidentship or resigns, the Vice Principal of J. S. S. Dental College and Hospital, Mysore, shall be nominated as Acting president by the Executive Committee.

**08. THE VICE PRESIDENT:**

The Vice Principal of J. S. S. Dental College and Hospital, Mysore, shall be the Vice president of the Association throughout his tenure in the college. In the absence of the President, the Vice president shall look after the duties of the President after getting an express consent of the President

**09. THE SECRETARY:**

The Secretary shall be the Chief Executive Officer of the Association and he shall carry out the decisions and directions of the General Body and Executive Committee. He shall keep the minutes and records of the Association. All legal proceedings and documents by or in favour of the Association shall be executed in his name.

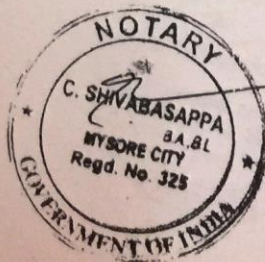
**10. THE TREASURER:**

The Treasurer shall be empowered to keep the finances and accounts of the Association. The funds shall be collected and utilized as said in para 16. He shall keep the accounts register and get audited every year before the annual general body. He shall present the audited account in the general body and get approved by the general body.

## 11. THE JOINT SECRETARY:

The Joint Secretary shall be the assistant to the Secretary and he shall help the Secretary in all his duties. In the absence of the Secretary, the Joint Secretary shall look after the duties of the Secretary after getting an express consent of the Secretary.

## 12. THE EDITOR:

The Editor shall be in charge of the official magazine of the alumni. He shall collect the necessary advertisement and sponsors for the smooth running of the magazine. The Editor/Editorial board members may receive all donations, both movables and immovables for the above purpose by giving proper receipt of the Association. The funds shall be deposited in the common account as said in para 16 (C). The Treasurer shall release the expenses towards the magazine.

## 13. THE EDITORIAL BOARD:

The Editorial Board consists of the Editor and six other members nominated by the Executive Committee from the members. The President, Vice president the Secretary and the Treasurer shall be the ex-officio members. Nominated members shall not be a member of the Executive Committee.

## 14. THE NEWS LETTER:

A yearly publication shall be the official magazine of the alumni and may use this medium to give publicity to its activities and up-to-date the scientific knowledge to all the members of the Association based on the current developments, researches and innovations in the field of dentistry.

## 15. PROGRAMME COMMITTEE:

The Executive Committee including the President, Vice president Secretary and Treasurer form themselves a Programme Committee to decide on the programs of the Association and their proper execution.

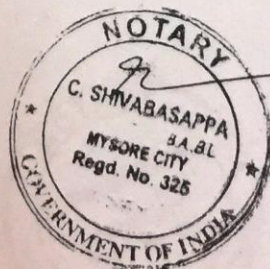
## 16. FUNDS:

A) The assets both movables and immovables may be received by the President/Secretary/Treasurer or the members by giving proper receipt of the Association.

B) The income of the Association by whatever means it might derive shall be utilized for the purpose of the objects of the Association and shall not be distributed among the members of the Association.

C) The funds of the Association shall be deposited in a nationalized, scheduled or a Co-operative bank in the name of the Association to be operated by the President and Treasurer. Any withdrawal of fund from the account shall be after the approval of executive committee.

**17. COMMON SEAL:**

The Association will have a common seal, which shall be in the custody of the Secretary.

**18. GENERAL BODY:**

A) The Annual General Body of the Association shall be held once in a year for the approval of annual accounts and election of new office bearers. Notice of annual meeting and agenda there of shall be sent to all members under certificate of posting at least 45 days prior to the date of meeting. Quorum of General Body shall be 1/3rd of the total membership or 50 whichever is less.

B) Extra Ordinary meeting of General Body shall be convened when Executive Committee so directs or when requested in writing by 1/3rd of the members of the Association specifying the objects for which the meeting is to be convened.

**19. AMENDMENT OF CONSTITUTION:**

The constitution may be amended by addition, deletion, alteration or substitution of the clauses at a meeting of the General Body under due notice to all the members (UPC) by a resolution passed by 2/3rd majority of total number of the members present during the voting

**20. REMOVAL OF OFFICE BEARERS:**

Any office bearer of the Association except the President and Vice president can be removed from office at any time by passing a "no-confidence resolution" in the General Body meeting held for that purpose.

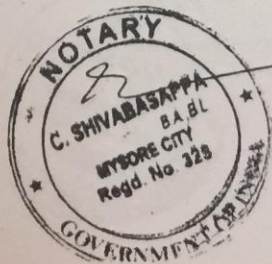

**21. DISSOLUTION:**

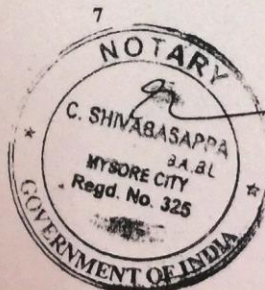
