

ADDENDUM TO THE RESEARCH AGREEMENT

This Addendum is entered into with effect from the 1st day of April 2016 in furtherance to the Research Agreement dated October 21, 2010 (hereinafter "Principal Agreement") executed by and between:

JSS UNIVERSITY MYSORE, Bangalore Mysore Road, Sri Shivarathreeswara Nagara, Mysore, Karnataka 570015 (hereinafter referred as the "JSS" which expression unless it be repugnant to the context or meaning thereof shall mean and include its successors and permitted assigns) of the FIRST PART;

AND

THE HIMALAYA DRUG COMPANY., a partnership firm registered under The Partnership Act, 1932, having its principal place of business situated at Makali, Bangalore - 562 162 (hereinafter referred as "Himalaya" which expression unless it be repugnant to the context or meaning thereof shall mean and include its successors and assigns) of the OTHER PART;

JSS and Himalaya are hereinafter jointly referred to as "Parties" and severally as "Party".

NOW THIS ADDENDUM WITNESSETH AS FOLLOWS:

A. GENERAL

1. The Principal Agreement dated October 21, 2010 was executed between the parties for Facilitating collaborative Research a Development in the areas of new drug discovery and clinical studies; and
2. The Parties have agreed to be bound by the terms and conditions contained in the Principal Agreement *mutatis mutandis* (subject to changes as may be required by the execution of this Addendum). The Principal Agreement shall continue to remain in force and bind the parties and shall form part of this Addendum and a copy thereof signed by the Parties is annexed hereto.
3. As expressly amended hereby, the terms and conditions of the Principal Agreement shall continue in full force and effect and are hereby confirmed and ratified.
4. If there is inconsistency between the Principal Agreement and this Addendum, the provisions of this Addendum shall prevail.
5. The terms and expressions not defined herein but used in this Addendum shall, unless repugnant to the context or meaning thereof, have the same meanings as attributed to them in the Principal Agreement.
6. The Parties acknowledge, agree and confirm that (i) they have the requisite power and authority to execute this Addendum and to perform their obligations hereunder, and have duly authorized, executed and delivered this Addendum (ii) they are not required to obtain any authorization, consent, approval, exemption or license from, or to file any

registration with, any government authority as a condition to the validity of, or to the execution, delivery or performance of, this Addendum and (iii) this Addendum constitutes the legal, valid and binding obligation of such Party enforceable in accordance with its terms.

7. The Parties shall do all such acts and things necessary or desirable to give effect to the Addendum effected or to be effected pursuant to the Addendum.

B. ADDENDUM:

Now the Parties above-agree to the following addendum to the existing Principal Agreement:

Substitute the whole of clause 5.1 with the new clause 5.1 as follows:

- 5.1 This Agreement shall be extended for period of 5 (five) years from the date of execution of this addendum basis upon the same terms and conditions as contained in the Principal Agreement. The new termination date shall be 31.03.2021.


Insert after clause 5.2 the new clause 5.3 as follows:


- 5.3 Either Party may terminate the Agreement by written notification signed by the authorised signatory of Party initiating the notice. Such notice must be received by the other Party 3 (three) months prior to the effective termination date.
